Executive Summary

The City of Martinsburg is a Class II city located in Berkeley County in the Eastern Panhandle of West Virginia. Martinsburg is the regional hub for Jefferson, Berkeley and Morgan Counties.

The City of Martinsburg was accepted into the Home Rule Pilot Project by the Home Rule Board on October 6, 2016, The City has implemented many of the proposals from the original application.

The City proposes to enact an ordinance permitting any private club licensee or private wine bed and breakfast or restaurant to serve beer, wine, and alcoholic liquors after the hour of 10:00 a.m. on Sundays.

Section II: Narrative

Introduction

At the heart of Berkeley County lies its county seat, the City of Martinsburg. This vibrant city offers the very best of modern living, while respecting its historic past. Recognized as the fastest growing city in the state, Martinsburg is not only a great place to live, but also a great place to do business.

Through several downtowny revitalization projects, the expansion of interstate-related commerce, economic development initiatives, transportation projects, and infrastructure modernization efforts, Martinsburg's leadership continually demonstrates its dedication to fostering community and economic development. This dedication continues to attract businesses, bring more jobs to the City and increase access to products and services. By building a strong economic foundation, Martinsburg continues to be a place that local residents love to call home.

Residents enjoy a wide variety of recreation, entertainment, and shopping opportunities, while benefiting from the city's close proximity to the major metropolitan areas of Washington, D.C. and Baltimore, Maryland. From annual festivals to numerous cultural events, recreation, and performing arts venues, Martinsburg truly offers something for everyone.

Specific Problems and Solutions to be addressed by Martinsburg's Home Rule Plan

A. Regulate When Restaurants May Serve Alcohol to Become a Sunday Brunch Destination.

- i. Problem: West Virginia Code prohibits restaurants and bars from serving alcohol before 1:00 p.m. on Sundays. However, nearby Maryland and Virginia permit sales of alcohol at least two hours earlier, at 11:00 a.m. Martinsburg is home to several dining establishments that lose significant business as patrons travel across state lines to enjoy alcoholic beverages with their Sunday brunches.
- ii. Authority: W. Va. Code § 60-7-12(a)(5) prohibits any private club licensee, or agent, employee or member thereof, from selling beer, wine, or alcoholic liquor between the hours of 3:00 a.m. and 1:00 p.m. on Sundays. Further, W. Va. Code § 60-8-34 prohibits a private wine bed and breakfast or restaurant from selling wine between the hours of 2:00 a.m. and 1:00 p.m. on Sundays. W. Va. Code § 11-16-18(a)(1) provides that it shall be unlawful for any licensee to sell beer between 2:00 a.m. and 1:00 p.m. on Sundays (except that private clubs licensed under Article 7, Chapter 60 of the West Virginia Code shall operate within hours conforming with the hours of sale of alcoholic liquor). The Governor recently signed SB 298 that authorizes County Commissions to authorize a referendum to allow alcohol sales prior to 1 pm on Sunday.
- iii. Solution: The City will enact an ordinance permitting any private club licensee or private wine bed and breakfast or restaurant to serve beer, wine, and alcoholic liquors after the hour of 10:00 a.m. on Sundays.

To the extent required by law, this plan shall terminate on or prior to the first day of July, 2019; however, all ordinances enacted under the provisions of this plan shall continue in full force and effect until repealed. Further, the City of Martinsburg will cooperate fully with any performance review conducted by the Joint Committee on Government and Finance and provide progress reports to the Home Rule Board as needed.

The above-mentioned solution will allow for sustained improvement to the City of Martinsburg.


Re: Application for Amendment of the City of Martinsburg Home Rule Application

Ladies and Gentlemen:

We have acted as counsel to the City of Martinsburg in connection with its amendment to its approved Home Rule Application. For purposes of the opinions contained in this letter, we have examined West Virginia Code § 8-1-5a,, the Municipal Home Rule Pilot Program Phase II Application of the City of Martinsburg and Amendment. As to any facts relevant to our opinion which we did not independently establish, we have relied upon factual representations contained within the Application and documentation submitted contemporaneously therewith.

We find that the application for Amendment for Amendment does not include proposals that will make changes to ordinances, acts, resolutions, rules, and regulations contrary to environmental laws, bidding on government construction and other contracts, the Freedom of Information Act, the Open Governmental Proceedings Act, wages for construction of public improvements, the provisions of West Virginia Code § 8-1-5a, the provisions of West Virginia Code § 8-12-5a, and the City of Martinsburg's written plan. Further, we find that the Application does not propose to pass any ordinance, act, resolution, rule, or regulation pertaining to the Constitution of the United States, the Constitution of the State of West Virginia, Federal law or crimes and punishment, Chapters 60A, 61, and 62 of the West Virginia Code or other state crimes and punishment, pensions or retirement plans, annexation, taxation, tax increment financing, extraction of natural resources, persons or property outside the boundaries of the municipality, marriage and divorce laws, or an occupation tax, fee, or assessment payable by a nonresident of a municipality, except to the extent that the Application proposes a municipal sales tax of up to one percent in connection with the reduction of the City of Martinsburg's Business and Occupation Tax, as permitted by West Virginia Code § 8-1-5a(k)(6).

Finally, as evidenced by the documentation enclosed with the Amendment for Amendment, the City of Martinsburg made available a copy of the Amendment for Amendment for

public viewing and published thirty days' advance notice of a public hearing on the Amendment for Amendment, conducted such a public hearing, and adopted an ordinance authorizing the City of Martinsburg to submit the Amendment for Amendment. Further, as evidenced by the documentation enclosed with the Amendment for Amendment, the City of Martinsburg is current in payment of all state fees.

Based upon the foregoing, we opine that the City of Martinsburg's Amendment for Amendment does not violate the provisions of West Virginia Code § 8-1-5a. This opinion is solely for the benefit of the Municipal Home Rule Board in connection with the Application of the City of Martinsburg to the WV Municipal Home Rule Pilot Program Phase II, and without our written consent, this opinion letter may not be used or relied upon by any other person for any purposes whatsoever.
